CANCELLATION OF GROUND LEASE AND BUILDING PURCHASE OPTION

THIS AGREEMENT is made as of this 26th day of September, 1995 by and between MACNEAL HEALTH SERVICES CORPORATION, an Illinois not-for-profit corporation ("MacNeal"), and BMR, LIMITED, an Illinois limited partnership ("BMR, Limited").

WHEREAS, MacNeal, as landlord, and Berwyn Magnetic Resonance Center (BMRC), as tenant, entered into an executed a Ground Lease dated December 31, 1984, demising the premises located at the northeast corner of South Oak Park Avenue and 34th Street, Berwyn, Illinois, 24 legally described in the Ground Lease ("Premises"); and

1. The Agreements are hereby cancelled as of this date and each oaity hereto releases and forever discharges the other from any liabilities or obligations under the Agreements.
