In the event of loss or damage to the Premises, we will immediately notify you in writing and file a proof of loss with the insurer. You may file a proof of loss on our behalf if we fail or refuse to do so. You may also sign our name to any check, draft or other order for the payment of insurance proceeds in the event of loss or damage to the Premises. If you receive payment of a claim, you will have the right to choose to use the money either to repair the Premises or to reduce the amount owing on the Note.

- (d) CONDEMNATION: We assign to you the proceeds of any award or claim for damages, direct or consequential, in connection with any condemnation or other taking of the Premises, or part thereof, or for conveyance in lieu of condemnation, all of which shall be paid to you, subject to the terms of any Prior Mortgage.
- (c) SECURITY INTEREST: We will join with you in signing and filing documents and, at our expense, in doing whatever you believe is necessary to perfect and continue the perfection of your lien and security interest in the Premises.
- (f) OUR AUTHORITY TO YOU: If we fail to perform our obligations under this Mortgage, you may, if you choose, perform our obligations and pay such costs and expenses. You will add the amounts you advance to the sums owing on the Note, on which you will charge interest at the interest rate set forth in the Note. DEFAULT: Except as may be prohibited by applicable law, and subject to any advance notice and cure period if required by applicable law, if any event or condition described in Paragraph 12.A. of the Note occurs, you may foreclose upon this Mortgage. This means that you may arrange for the Premises to be sold, as provided by law, in order to pay off what we owe on the Note and under this Mortgage. If the money you receive from the sale is not enough to pay off what we owe you, we will still owe you the difference which you may seek to collect from us in accordance with applicable law. In addition, you may, in accordance with applicable law, (i) enter on and take possession of the Premises; (ii) collect the rental payments, including over-due rental payments, directly from tenants; (iii) manage the Premises; and (iv) sign, cancel and change leases. #### RIDER TO MORTGAGE/DEED OF TRUST (Line of Credit)

This Filder amends the attached Mortgago/Doed of Trust made this 26th day of September , 1995 between MICHAEL A ADAMS MARY A ADAMS

("Borrower" or "I" or "we") and COUNTRYWIDE FUNDING CORPORATION ("Lender" or "you").

MEANING OF WORDS. Except as modified in this Rider, the words used in this Rider have the meanings ascribed to them in the Mortgage/Deed of Trust.

AMENDMENTS. The following amendments are made by this Rider to the BORROWER'S IMPORTANT OBLIGATIONS section of the Mortgage/Deed of Trust:

- 1. Paragraph (i) SALE of ATEMISES is amended to read as follows:
  - "(i) TRANSFER OF OR FAILURE TO OCCUPY THE PREMISES: If without Lender's prior written consent, all c. any part of the Premises or any interest in it is sold or transferred or Borrower fails to occupy the Premises, Lender may, at Lender's option require immediate payment in full of all sums served by this Mortgage/Deed of Trust. However, this option shall not be exercised by Lender if excroise is prohibited by federal law as of the date of this Mortgage/Deed of Trust. Nor will this option be exercised when the transfer or sale is (1) to Borrower's spouse as a result of Dorrower's death and Borrower's spouse is also obligated under the Agreement and Mortgage/Deed of Trust; (2) to Borrower's spouse where Borrower's spouse becomes a co-owner of the Premises; (3) to Borrower's spouse as a result of a decree of dissolution of marriage, a egal separation agreement or from an incidental property settlement agreement which requires be grower to continue to make loan payments; (4) into an inter vivos trust in which Borrowei is a beneficiary; or (5) such that the Premises are made subject to a junior encumbrance or lien.
- 2. A new paragraph (j) ENCUMBRANCE OF PREMISES is added as follows:
  - "(j) ENCUMBRANCE OF PREMISES: We will not parroit any other lien or claim against the Premises without your prior written consent."
- Paragraph (j) INSPECTION is renumbered as paragraph (k).

EFFECTIVE DATE OF AMENDMENTS. The amendments to the Mortgage/Died of Trust which are being made by this Rider shall take effect on the date the Mortgage/Deed of Trust is signed.

OTHER TERMS OF MORTGAGE/DEED OF TRUST UNAFFECTED. Except as specifically amended by this Rider, all other terms and conditions of the Mortgage/Deed of Trust shall remain in full force and effect. In the event of any inconsistency between the Mortgage/Deed of Trust and this Rider, the provisions of this Rider shall control.
