

The right to such proceeds and the use of such proceeds shall be governed by, and applied in accordance with, the provisions of Covenant 28 of this Rider as if such proceeds were hazard or property insurance proceeds.

Covenant 14 of this Mortgage is deleted.

DUE ON FURTHER ENCUMBRANCE 32.

The text of Covenant 16 of this Mortgage is deleted and replaced with the following:

If Borrove, se is, transfers or further encumbers all or any part of the Property or an interest therein, or allows an interest therein to be obtained by a third party, without Lender's prior written consent, Lender may declare all of the sums secured by this Mortgag, to be immediately due and payable.

LENDER'S RIGHTS OF BORROWER PAILS TO KEEP PROMISES AND AGREEMENTS 33.

The text of Covenant 17 of this Mortgage is deleted and replaced with the following:

35. ASSIGNMENT OF RENTS
