Standard Federal Saving: As ociation ("SFSA") is an institution now in conservatorship and the Resolution Trust Corporation has appointed as Conservator therefor by OTS Order No. 92-451 dated October 21, 1992; and

Poissuant to the terms of that cerain Purchase and Assumption Agreement between the Resolution Trust Corporation as Receiver for SFSB and the Resolution Trust Corporation as Conservator for SFSA dated October 21, 1992, substantially all of the assets of SFSB, including the asset referenced herein, were transferred to SFSA.
