Standard Federal Savings Association ("SFSA") is an institution now in conservatorship and the Resolution Trust Corporation has been profuned as Conservator therefor by OTS Order No. 92-451 dated October 21, 1992; and

Pursuant to the terms of that cerain Psychase and Assumption Agreement between the Resolution Trust Corporation as Receiver for SF, B and the Resolution Trust Corporation as Conservator for SFSA dated October 21, 1992, substantially all cr the assets of SFSB, including the asset referenced herein, were transferred to SFSA.
