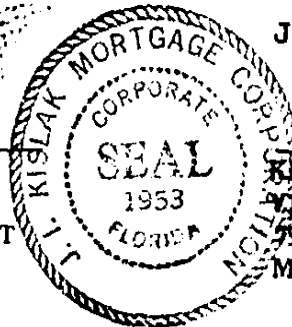

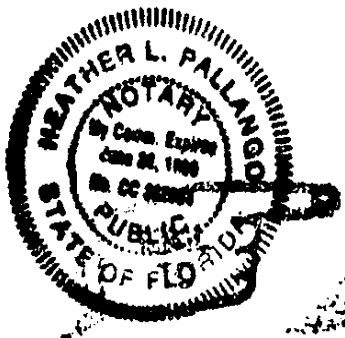

RIDER - LEGAL DESCRIPTION

PARCEL 1: THAT PART OF THE NORTHWEST 1/4 OF SECTION 17, TOWNSHIP 40 NORTH, RANGE 13, EAST OF THE THIRD PRINCIPAL MERIDIAN, LYING NORTH OF THE INDIAN BOUNDARY LINE DESCRIBED AS FOLLOWS: COMMENCING AT A POINT 195.27 FEET EAST OF THE WEST LINE OF SECTION 17 AND 1493 FEET SOUTH OF THE NORTH LINE OF SECTION 17, THENCE WEST ALONG A LINE PARALLEL TO THE NORTH LINE OF SECTION 17, 195.35 FEET TO THE EASTERLY LINE OF NAGLE AVENUE THENCE SOUTHEASTERLY ON THE EASTERLY LINE OF NAGLE AVENUE TO THE INTERSECTION OF A LINE 1543 FEET SOUTH OF THE NORTH LINE OF SECTION 17, THENCE EAST ALONG A LINE PARALLEL TO THE NORTH LINE OF SECTION 17, 82 FEET, THENCE NORTH PARALLEL TO THE WEST LINE OF SECTION 17, 50 FEET, TO THE POINT OF BEGINNING, ALL IN NORWOOD TOWNSHIP, IN COOK COUNTY, ILLINOIS.
