#### MORTGAGE

THIS MORTGAGE IS DATED OCTOBER 16, 1995, between WILLIAM K. HOPPE and PATRICIA L. NOVAK, HIS WIFE, AS JOHNT TENANTS, whose address is 802 BOWNE BROOK DRIVE, PROSPECT HEIGHTS, IL 60070 (referred to below as "Grantor"); and LaSalle Talman Bank, FSB, whose address is 4747 W. Irving Park Road, Chicago, IL 60641 (referred to below as "Lender").

GRANT OF MORTGAGE. interest with a term greater than three (3) years, lease-option contract, or by sale, assignment, or transfer of any beneficial interest in or to any land trust holding title to the Real Property, or by any other method of conveyance of Real Property interest. Payment. Right To Contest. Grantor may withhold payment of any tax, assessment, or claim in connection with a good faith dispute over the obligation to pay, so long as Lender's interest in the Property is not jeopardized. PROPERTY DAMAGE INSURANCE. The following provisions installing to insuring the Property are a part of this Mortgage.

Maintenance of Insurance. Grantor shall procure and maintain policies of fire insurance with standard extended coverage endorsements on a replacement basis for the full insurable value covering all improvements on the Real Property in an amount sufficient to avoid application of any consurance clause, and with a standard mortgagee clause in favor of Lender. Policies shall be written by such insurance companies and in such form as may be reasonably acceptable to Lender.
