(A) Change Dates

The interest rate I will pay may change on the first day of April , 1996, and on that day every sixth month thereafter. Each date on which my interest not could change is called a "Change Date."

(B) The Index

Beginning with the first Change Date, my interest rate will be based on physicalex. The "Index" is the average of interbank offered rates for six-month U.S. dollar-denominated deposits in the London market ("LIBOR"), as published in The Wall Street Journal. The most recent Index figure available as of the date 45 Pays before each Change Date is called the "Current Index."
