Claimant also hereby files a Notice and Claim for Lien against ROADWORKS, INC. ("ROADWORKS"), the general contractor for said project, who was authorized and/or knowingly permitted by OWNER to provide construction work on the LAND.

On or before July 6, 1995, the OWNER of said property made a contract with ROADWORKS whereby ROADWORKS was to provide labor, material, tools and equipment for construction for said project; and on or about July 6, 1995, ROADWORKS and TIGER entered into an oral subcontract whereby TIGER was to provide concrete and related materials for said project; TIGER thereafter completed all of its obligations pursuant to said subcontract on or about July 18, 1995.
