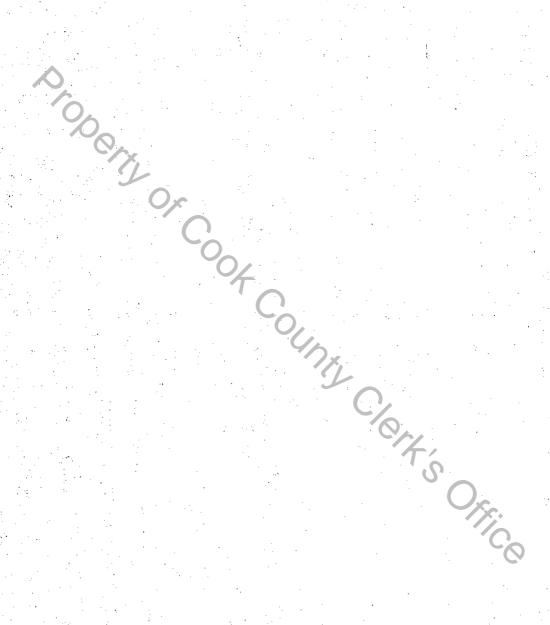

* 8.
