The grant of Mortgage is on the condition that where is dortgagor is justly indepted unto Mortgagee in the sum of <u>FIGUTEEN</u>
THOUSAND EIGHT HUNDED <u>FIGHTY</u> Pollars (\$ 18.80.00), evidenced by one retail installment contract ("The Contract") of even execution date, in the sum of \$ 18,30.00, bearing interest from date until due as provided in the contract, payable in <u>240</u> equal successive monthly installments of 3.755.161 each, except the final installment, which shall be the balance then due on the contract.

This instrument shall also secure the payment of any and all renewals and/or extensions of said indebtedness, or any portion hereof together with any and all amounts that the Mortgagor now owes or may one in Mortgagoe, either direct or by endorsement, at any time between this date and the satisfaction of record of lien of this instrument, including any and all future advances that may by Mortgagee be made to the Mortgagor jointly and/or severally, either direct or by endorsement.

Mortgagors and Mortgagee acknowledge and represents that a material part of the consideration for the indebtedness owed by Mortgagors to Mortgagee is that the entire unpaid balance of principal and accrued interest due on said indebtedness shall be paid prior to the sale, transfer, encumbrance, contract of sale, contract to transfer or contract for encuriber all or any part of or interest in the Mortgaged property.
