

RESOLUTION

BE IT RESOLVED, the unit owners of Point Loma Condominium Association (the "Association") hereby agree to amend Article V of the Declaration of Condominium Ownership for Point Lorna Condominium as follows

- The Board of the Association shall assign the five on-site garage (1)spaces, first on basis of owner occupancy, then based on length of ownership.
- The Association shall pay for the sixth off-site parking space out (2) of the General Fund, reserving the right to approve the choice of said space.
- (3) An owner who relinquishes occupancy, whether by lease or any other means, loses his or her seniority, and shall be treated as if a new owner.
