ORDER

This matter coming on to be heard upon the motion of plaintift New Asia Bank (the "Bank") filed on December 22, 1993, seeking an award of attorneys' fees and costs incurred to date in connection with this matter and the Bank's motion for entry of a finding pursuant to Supreme Court Rule 304(a), filed on February 2, 1994 (collectively, "Bank's Motions"); due notice having been given; the Court having conducted an evidentiary hearing on January 27, 1994 as to Bank's motion for attorneys' fees and costs;

Based upon the Bank's Motions, the Wu's Response filed on January 12, 1994, the evidentiary bearing held on January 27, 1994 and the arguments of counsel, the Court finds as follows:

- 1. The plaintiff is entitled to recovery of its expenses and costs, including attorneys' fees, incurred in connection with enforcing its rights under the promissory note and guarantees upon which this action is premised;
- 2. The Wu's are not responsible for the costs and expenses relating to the filing of the complaint against Shie-Ling Liu Chen and Hung-Jung Huang ("Guarantors") or any defense or pleading filed by the Guarantors which was not joined in by the Wu's;
- on November 24, 1923 granting plaintiff's motion for summary judgment or this order granting the plaintiff's motion for attorneys' fees and costs.

IT IS HEREBY ORDEREIA

- 1. The Bank is entitled to ar averal of atterneys' fees and costs in connection with this case against the Guaranters, jointly and severally, in the amount of \$12,806.77;
- 2. The Bank is entitled to an award of atterpeys' fees and costs in connection with this case against the Wu's, jointly and severally, in the amount of 3 9,813.50 such award to be joint and several with the award of atterneys' fees and costs entered in Bank's favor and against the Guaranters pursuant to paragraph 1 above;
- 3. The Bank's motion for entry of a finding pursuant Supreme Come 2016 304(a) is granted as to the order entered on November 24, 1993 granting summary judgment in Cave: of the Bank and as to this order;
- 4. The Bank is granted leave to make subsequent applications for attorneys' fees and other allowances pursuant to the various foun documents in the event additional expenses are incurred; and

The Bank's costs for the filing fees for the complaints initiating this action and the fees for service of the summons and complaint are included within the awards provided for in paragraphs 1 and 2 above, and shall be excluded from the costs which are otherwise recoverable as part of judgments under applicable liling law.
