GRANTOR'S WAIVERS. Grantor waives all rights or detenses arising by reason or ray "one action" or "anti-deficiency" law, or any other law which may prevent Lender from bringing any action against Grantor, including a claim for deficiency to the extent Lender is otherwise emitted to a claim for deficiency, before or after Lender's commencement or completion of any foreclosure action, either judicially or by exercise of a power of sale.

GRANTOR'S REPRESENTATIONS AND WARRANTIES. Ownership. Circutor is entitled to receive the Rents free and clear of all rights, loan, tions, encumbrances, and claims except as disclosed to and accepted by Leader in writing.

Right to Assign. Crantor has the full right, power, and authority to enter into this Assignment and to assign and convey the Rents to Lender.

LENDER'S RIGHT TO COLLECT RENTS. Lender shall have the right at any time, and even though no default shall have occurred under this Assignment, to collect and receive the Routs. For this purpose, Lender is hereby given and granted the following rights, powers and authority:

Notice to Tenants. Lender may send notices to say and all tenants of the Property advising them of this Assignment and directing all Rents to be paid directly to Lender of Fooders' agent.

Enter the Property. Maintain the Property. FULL PERFORMANCE. If Grantor pays all of the Indebtedness when due and otherwise performs all the obligations imposed upon Grantor under this Assignment, the Note, and the Related Documents, Londor shall execute and deliver to Grantor a suitable satisfaction of this Assignment and suitable statements of termination of any financing statement on file evidencing Lendor's security interest in the Rents and the Property. If such a failure is curable and if Granter or Horrower has not been given a notice of a breach of the same provision of this Assignment within the preceding twelve (12) nonths, it may be cared (and no Event of Default will have occurred) if Granter or Borrower, after Lender sends written notice demanding cure of such failure: (a) cures the failure within fifteen (15) days; or (b) if the cure requires more than fifteen (15) days, immediately initiates steps sufficient to cure the failure and thereafter continues and completes all tensonable and necessary steps sufficient to produce compliance as soon as reasonably practical.

False Statements. Any warranty, representation or statement made or farnished to Lender by or on behalf of Granter or Horrower under this Assignment, the Note or the Related Documents is false or misleading in any material respect, either new or at the time made or farnished.

Other Defaults. Failure of Granter or Borrower to comply with any term, obligation, convenant, or condition contained in any other agreement between Granter or Borrower and Lender.

Death or Insolvency. Foreclosure, Forfeiture, etc. Commencement of foreclosure or forfeiture proceedings, whether by judicial proceeding, self-help, repossession or any other method, by any creditor of Grantor or by any governmental agency against any of the

Property. However, this subsection shall not apply in the event of a good faith dispute by Grantor as to the validity or reasonableness of the claim which is the basis of the foreclosure or forfeiture proceeding, provided that Grantor gives Lender written notice of such claim and furnished reserves or a surety bond for the claim satisfactory to Lender.

Events Affecting Guarantor. Any of the preceding events occurs with respect to any Guarantor of any of the Indebtedness or such Guarantor dies or becomes incompetent. Lender, at its option, may, but shall not be required to, permit the

Guarantor's estate to assume unconditionally the obligations arising under the guaranty in a manner satisfactory to Lender, and in doing so, cure the Event of Default.

Insecurity. Lender reasonably deems itself insecure.
