ORDER

THIS CAUSE COMING BEFORE the Court for Prove-Up hearing, due notice having been given and the Court having heard the testimony and evidence, the Court finds as follows:

IT IS HEREBY ORDERED:

1. As to Count I, the Court declares the Quit Claim Deed from Juan G. Rocha and Guadalupe Rocha and Eduardo Vazquez to E.J. Belluomini to the property legally described as:

Lot 21 in Block 5 in Cass Subdivision of the East 30 Acres of the South 64 acres of the Northwest 1/4 of Section 25, Township 39 North, Range 13 East of the Third Principal Meridian, in Cook County, Illinois

dated February 20, 1993 and recorded on January 17, 1995 as Document No. 95037099 by the Cook County Recorder of Deeds is null and void and of no force and effect.

2. As to Count II, plaintiffs' Motion for a Voluntary Dismissal is granted.

3. Any relief sought under Count III is entered and continued pending further submission regarding damages by plaintiff until December 18, 1995 at 10:30 a.m. Courtsey copies of all submissions shall be made on or before December 4, 1995.

4. A copy of this order shall be served on defendant by regular and certified mail to Emmanuel Belluomini. A motion to dismiss the consolidated forcible action may be presented for hearing upon proper notice on December 18, 1995 at 10:30 a.m. in Room 2302.

5. Plaintiff is granted leave to withdraw group Exhibit 6 and is granted leave to file a copy thereof.

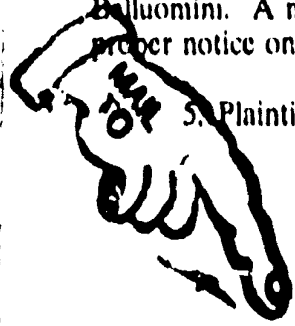

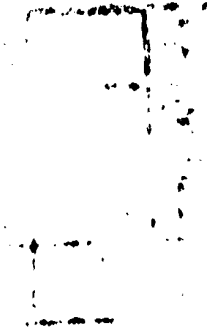
