Borrower covenants that Borrower is lawfully seized of the estate hereby conveyed and has the right to mortgage, grant and

- 3. CHARGES, LIEND: Borrower shall promptly pay all obligations secured by a mortgage or trust deed affecting the Property; taxes, assessmen's and other charges, fines and impositions attributable to the Property which may attain a priority over this Mortgage, and leaseful payments or grounds rents, if any, when due. Borrower shall promptly furnish to Lender all notices of amounts due under this pringraph, and in the event Borrower shall make payment directly. Borrower shall promptly furnish to Lender receipts evidencing such payments. Borrower shall promptly discharge any lien which has priority over this Mortgage with respect to any sum, including, but not limited to, Future Advances.
- 4. Unless Lender and Borrower otherwise agree in writing, insurance proceeds shall be applied to restoration or repair of the Property damaged, provided such restoration or repair is economically feasible or if the security of this Mortgage would be impaired, the insurance proceeds shall be applied to the sums secured by this Mortgage, with the excess, if any, paid to Borrower. - 5. PRESERVATION AND WALITEVENCE-OF PROPERTY, LHASE HOLDS, CONDOMINIUMS, PLANNED UNIT DEVELOPMENTS: Borrower shall keep the Property in good repair and shall not comunit waste or permit impairment or deterioration of the Property and shall comply with the provisions of any lease if this Mortgage is on a leasehold. If this Mortgage is on a unit in a condominium or a planned unit development, Borrower shall perform all of Borrower's obligations under the declaration or covenants creating or governing the condominium or planned unit development, the bylaws and regulations of the condominium or planned unit development, and constituent documents.
