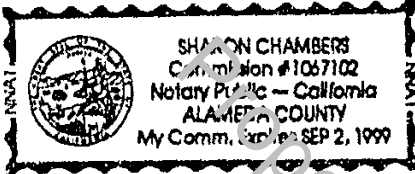


EXHIBIT "A": LEGAL DESCRIPTION
