TOGETHER with all the improvements now or hereafter erected on the property, and all easements, rights, apportenances and rents, all of which shall be deemed to be and remain a part of the property covered by this Security Instrument. All of the foregoing, together with such property (or the leasehold estate if this Security Instrument is on a leasehold) are called the "Property."
