MURTGAGE

THIS MORTGAGE IS DATED NOVEMBER 1, 1995, between Chicago Title and Trust Company Under Trust Agreement #1090909 Dated May 19, 1988, whose address is 171 North Clark Street, Chicago, IL 60601-3294 (referred to below as "Grantor"); and Peterson Bank, whose address is 3232 W. Peterson, Chicago, IL 60659-3692 (referred to below as "Lender").

Compliance with Governmental Requirements. DUE ON SALE - CONSENT BY LENDER. Lender may, at its option, declare immediately due and payable all sums secured by this Mortgage upon the sale or transfer, without the Lender's prior written consent, of all or any part of the Real Property, or any interest in the Real Property. A "sale or transfer" means the conveyance of Real Property or any right, title or interest therein; whether legal, beneficial or equitable; whether voluntary or involuntary; whether by outright sale, deed, instalment sale contract, land contract, contract for deed, leasehold interest with a term greater than three (3) years, lease-option contract, or by sale, assignment, or transfer of any beneficial interest in or to any land trust holding title to the Real Property, or by any other method of conveyance of Real Property interest. Payment. Grant or shall pay when due (and in all events prior to delinquency) all taxes, payroll taxes, special taxes, assessments, viater charges and sewer service charges levied against or on account of the Property, and shall pay when due all claims for work done on or for services rendered or material furnished to the Property. Right To Contest. Grantor will upon request of Lender furnish to Lender advance assurances satisfactory to Lunder that Grantor can and will pay the cost of such improvements.

PROPERTY DAMAGE INSURANCE. The following provisions relating to insuring the Property are a part of this Mortgage.

Maintenance of Insurance. Grantor shall procure and maintain policies of fire insurance with standard extended coverage endorsements on a replacement basis for the full insurable value covering all Improvements on the Real Property in an amount sufficient to avoid application of any coinsurance clause, and with a standard mortgagee clause in favor of Lender. Grantor shall also procure and maintain comprehensive general liability insurance in such coverage amounts as Lender may request with Le. der being named as additional insureds in such liability insurance policies.
