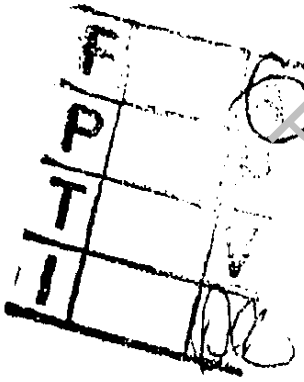

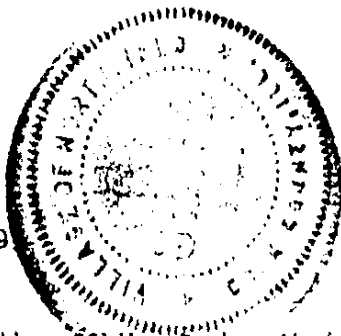

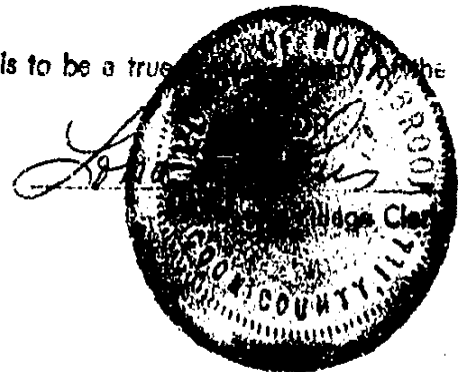

BE IT ORDAINED by the President and Board of Trustees of the Village of Northbrook, County of Cook and State of Illinois, THAT:

AN ORDINANCE VOLUNTARILY DISCONNECTING CERTAIN TERRITORY WITHIN THE VILLAGE OF NORTHBROOK

be and is hereby adopted as follows:

Section 1. BACKGROUND.

A petition for disconnection from the Village of Northbrook has been received which complies with the requirements of 65 ILCS 5/7-1-24. The petitioners desire to annex to the Village of Northfield in order to connect to that village's water system which can be accomplished more economically than connection to the Village of Northbrook system. Based upon the provisions of the state statute, the disconnection can be approved to be effective and recorded when the annexation to the Village of Northfield is approved and recorded.

Section 2. REAL ESTATE DISCONNECTED

The Village of Northbrook, pursuant to the Illinois Municipal Code, 65 ILCS 5/7-1-24 hereby disconnects the territory legally described as:

The North 112 feet of the South 220 feet of the West Half of the North 25 acres of the Southwest Quarter of the Northwest Quarter of Section 13, Township 42 North, Range 12 East of the Third Principal Meridian (except the West 270 feet thereof), all in Cook County, Illinois, commonly designated as 360 Riverdale Road, Northbrook, Illinois (PFEI No. 04-13-110-031).

Section 3. PLAT OF DISCONNECTION

A plat of the above described territory is attached hereto as Exhibit A and, by this reference, made a part hereof.

Section 4. EFFECTIVE DATE & RECORDATION

This Ordinance shall be effective upon the annexation of this property to the Village of Northfield and the recordation with the Cook County Recorder of Deeds by the Village Clerk of the Village of Northfield of that annexation and this disconnection ordinance. 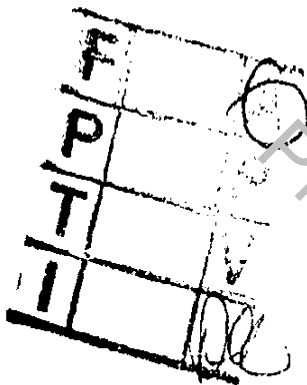

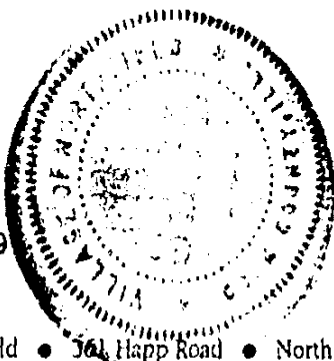

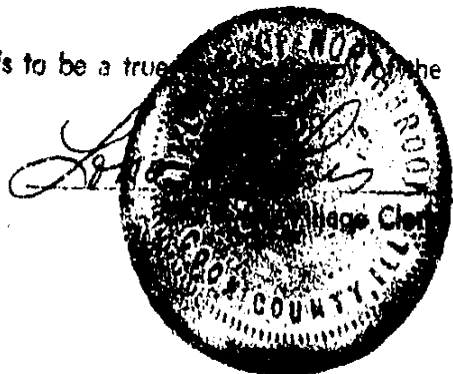
