MURTGAGE

THIS MORTGAGE IS DATED OCTOBER 30, 1995, between First National Bank of Evergreen Park as Trustee under Trust Agreement dated September 20, 1989, and known as Trust Number 10869, whose address is 3101 W. 95th Street, Evergreen Park, IL 60642 (referred to oplow as "Grantor"); and First American Bank, whose address is P.
