#### MODIFICATION TO MORTGAGE

THIS MODIFICATION to Mortgage (as hereinafter defined) (this "Modification") is entered into and effective the <a href="lst.">lst.</a> day of <a href="Movember">November</a>, 1995 between <a href="Barbara L. Rapp">Barbara L. Rapp</a>, an individual <a href="Divorced and Not Sinco Remarried">Divorced and Not Sinco Remarried</a> ("Borrower") and BANK OF AMERICA ILLINOIS, an Illinois banking corporation ("Bank").

- A. Borrower and Bank are parties to a Private Equity Line of Credit Agreement dated as of September 27, 1995 (the "Line of Credit Agreement") pursuant to which, Bank agreed to make a loan (the "Loan") to Borrower in an amount not to exceed \$25,000. The Loan is secured by a Mortgage ("Mortgage") executed by Borrower dated September 27, 1995 and recorded October 5, 1995 as Instrument No. 95677892 in the Official Records of Cook County, Illinois covering certain improved real property situated in Cook County, Illinois, more particularly described on Exhibit A attached hereto and made a part hereof. Capitalized terms used herein and not otherwise defined are used as defined in the Mortgage.
- B. Borrower has requested a change in interest payment date and Bank is willing so to do on the terms and conditions set forth herein.

NOW, THEREFORE, in consideration of the premises and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Borrower and Bank hereby agree as follows:

1. Change in Interest Payment Date The dates for payment of accrued interest on the Loan are hereby changed from monthly to annually with the first such payment being due January 15, 1996 and each January 15th thereafter throughout the term of the Loan.

#### 2. Miscellaneous.

- 2.1 Except as modified hereby, the Line of Credit Agreement and the Mortgage are unmodified and in full force and effect in accordance with their terms.
- 2.2 This Modification constitutes the entire agreement of the parties with respect to the subject matter hereof and shall supersede and replace all prior understandings and agreements. This Modification may not be modified or amended orally, but only in a writing duly executed by both parties hereto.
- 2.3 This Modification shall be binding upon, and shall inure to the benefit of, the parties hereto and their respective successors and assigns.
