2. Application of Payments. All payments received by Lender shall be applied first to interest, then to other
charges, and then to principal. 3. Charges; Liens. Borrower shall pay all taxes, assessments, charges, fines, and impositions attributable to

4. Hazard Insurance. This insurance shall be maintained in the amounts and for the periods that Lender requires. The insurance carrier providing the insurance shall be chosen by Borrower subject to Lender's approval which shall not be unreasonably withheld. If Borrower falls to maintain coverage described above, Lender may, at Lender's option, obtain coverage to protect Lender's rights in the Property in accordance with Paragraph 6.

All lasurance policies and renewals shall be acceptable to Lender and shall include a standard mortgage clause. Lender shall have the right to hold the policies and renewals. Borrower shall be in default if any forfeiture action or proceeding, whether civil or criminal, is begun that in Lender's good taith judgment could result in forfeiture of the property or otherwise materially impair the lien created by this Security Instrument or Lender's security Interest. - 11. Loan Charges. If the loan secured by this Security Instrument is subject to a law which sets maximum loan charges, and that law is finally interpreted so that the interest or other loan charges collected or to be collected in connection with the loan exceed the permitted limits, then: (a) any such loan charge shall be reduced by the amount necessary to reduce the charge to the permitted limit; and (b) any sums already collected from Bornower which exceeded permitted limits will be refunded to Borrower. In the ever that any provision or clause of this Security Instrument or the Agreement conflicts with applicable law, such con act shell not affect other provisions of this Security Instrument or the Agreement which can be given effect without the crinflicting provision. To this end the provisions of this Security Instrument and the
- 14. Assignment by Lender. Lender may a sign all or any portion of its interest hereunder and its rights granted herein and in the Agreement to any per on, trust, financial institution or corporation as Lender may determine and upon such assignment, such assignee shall nerr unon succeed to all the rights, interests, and options of Lender herein and in the Agreement, and Lender shall the euron have no further obligations or liabilities thereunder.
- 15. Transfer of the Property or a Beneficial interest in Borrower. Due on Sale.
