- (C)Borrower's Promises. You promise to:
 - (1) Pay all amounts when due under your Agreement, including interest, and to perform all duties of the loan agreement and/or this Mortgage.
 - (2) Pay all taxes, assessments and liens that are assessed against the Property when they are due. If you are notified by any governmental or regulatory authority that any removal or other remediation of any hazardous substance affecting the Property is necessary, you shall promptly take all necessary remedial actions in accordance with applicable environmental laws.

- (E) Default. If you do not keep the promises you made in this Mortgage or you fail to meet the terms of your Agreement, you will be in default. If you are in default, we may use any of the rights or remedies stated in your Agreement including but not limited to, those stated in the Default, Remedies on Default, and/or Reducing the Credit Limit paragraphs or as otherwise provided by applicable law. If we accelerate your outstanding balance and demand payment in full, you give us the power and authority to sell the property according to procedures allowed by law. The proceeds of any sale will be applied first to any costs and expenses of the sale, including the costs of any environmental investigation or remediation paid for by us, then to reasonable attorney's fees and then to the amount you owe us under your Agreement.
- (F) Due on Sale. If you sell or transfer all or any part of the Property or any interest in the Property without our prior written consent, the entire balance of what you owe us under your Agreement is due immediately.
- (G)Eminent Domain. You will allow us to inspect the Property on reasonable notice. This shall include the right to perform any environmental give tigation that we deem necessary and to perform any envi or mental remediation required under environmental law, any investigation or remediation will be conducted solely for our benefit and to protect our interests. If any term of this Mongage is found to be illegal or unenforceable, the other terms will still be in effect. This Agreement may secure "revolving credit" v defined in 815 ILCS 205/4.1. The revolving credit line shall be governed by and construed in accordance with the Illino's Financial Services Development Act, 175 ILCS 675/1, et. sec. Up in or at any time after the filing of a complaint to foreciese this mortgage, we shall be entitled to enter upon, take possession of and manage the Property and collect rents in person, by agent or by judicially appointed receiver without notice and before or after any judicial sale. You agree to pay all of our fees including attorney's fees, receiver's fees and court costs upon the filing of a foreclosure complaint.
