## PARTIAL RELEASE DEED

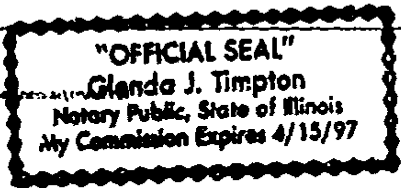

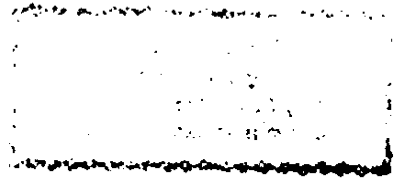
