You shall promptly give us written ce of any investigation, claim, demand, lawsuit or other in by any governmental or regulatory agency or privately involving the Property or release of any hazardous dance on the Property. If you are notified by any commental or regulatory authority that any removal or remediation of any hazardous substance affecting the perty is necessary, you shall promptly take all necessary edial actions in accordance with applicable roumental laws.

Mortgage or you fail to meet the terms of your Agreement, you will be in default. If you are in default, we may use any of the rights or remedies stated in your Agreement including, but not limited to, those stated in the Default, Remedies on Default, and/or Reducing the Credit Limit paragraphs or as otherwise provided by applicable law. If we accelerate your outstanding balance and demand payment in full, you give us the power and authority to self the property according to procedures allowed by law. - (II) Waiver of Homestead Right. You hereby release and waive all rights under and by virtue of the homestead exemption laws of the State of Illinois.
- Other Terms. We do not give up any of our rights by delaying or failing to exercise them at any time. Our rights ander the Agreement and this Mortgage are cumulative. You will allow us to inspect the Property on reasonable notice, This shall include the right to perform any environmental investigation that we deem necessary and to perform any environmental remediation required under environmental law. Any investigation or remediation will be conducted solely for our benefit and to protect our interests. If any term of this Mortgage is found to be illegal or unenforceable, the other terms will still by in effect. This Agreement may secure "revolving credit" as defined in 815 ILCS 205/4.1. The revolving credit line shall be governed by and construed in accordance with the Illinois Financial Services Development Act, 175 fLCS 675/1, et. seq. Open or at any time after the filing of a complaint to forcelose this mortgage, we shall be entified to enter upon, take possession of and manage the Property and collect rents in person by agent or by judicially appointed receiver without notice and define or after any judicial sale. You agree to pay all of our fees including attorney's fees, receiver's fees and court costs upon the filing of a foreclosure complaint.
