Borrower shall not be obligated to make such payments of Funds to Lender to the extent that Borrower makes such payments to the holder of a prior mortgage or

Il Borrower pays Punds to Lerder, the Punds shall be held in an institution the deposits or accounts of which are deed of trust if such holder is an institutional lender. insured or guaranteed by a Federal or state agency (including Lender il Lender is such an institution). Lender shall apply the Funds to pay said taxes, as ments, insurance premiums and ground rents. 9. Condemnation. 13. Governing Law: Severability. The state and local laws applicable to this Mortgage shall be the laws of the jurisdiction in which the Property is located. In the event that any provision or clause of this Mortgage or the Note conflicts with applicable law, such conflict shall not affect other provisions of this Mortgage or the Note which can be given effect without the conflicting provision, and to this end the provisions of this Mortgage and the Note are declared to be severable. The notice shall further inform Borrower of the right to reinstate after acceleration and the right to assert in the foreclosure proceeding the nonexistence of a default or any other defense of Borrower to acceleration and foreclosure. If the breach is not cured on or before the date specified in the notice, Lender, at Lender's option, may declare all of the sums secured by this Mortgage to be immediately due rad payable without further demand and may foreclosure, including, but not limited to, reasonable after entitled to collect in such proceeding all expenses of foreclosure, including, but not limited to, reasonable after established and costs of documentary evidence, abstracts and title reports.

18. Borrower's Right to Reinstate.
