FHA ADJUSTABLE RATE RIDER

THIS ADJUSTABLE RATE RIDER is made this 13th day of November, 1995 and is incorporated into and shall be deemed to amend and supplement the Mortgage, Deed of Trust or Security Deed ("Security Instrument") of the same date given by the undersigned ("Borrower") to secure Borrower's Note ("Note") to USA MORTGAGE CORPORATION

Lender's obligation to return any excess payment with interest on demand is not assignable even if the Note is otherwise assigned before the demand for return is made.
