

#### MEMORANDUM OF LEASE

This Memorandum of Lease is by and between Seger Enterprises, Inc., a corporation ("Landlord") and Progressive Bagei Concepts, Inc., a Delaware corporation ("Tenant"), pursuant to which Landlord has demised to Tenant, and Tenant has accepted such demise from Landlord, the Leased Premises (later defined) upon the following terms:

Date of Lease: November 9, 1955.

Legal Description of See Exhibit A attached hereto.

Description of Leased Premises: 2,250 square feet located Property (as defined in the Lease) and commonly known as 208 S. Cook Street, Barrington, Illinois.

Commencement Date: The Term of this Lease shall begin 57-120 days after Tenant obtains all Authorizations and Permits (as defined in the Lease).

Expiration Date: Sixty (60) full calendar months after Commencement Plate.

Term: Sixty (60) full calendar months.

Extension(s): Two (2), five (5) year renewal options.

Exclusive: As a material inducement for Tenant to enter into the Lease, Landlord acknowledges and agrees that during the Term and any Extension, Tenant shall have the exclusive right to sell bagels and bagel-related products and gourmet coffees for on or off-premises consumption at the Shopping Center Property.

Building Restrictions: Tenant has entered into this Lease in reliance upon representations by Landlord that no part of the Shopping Center shall be used as a massage parlor or spa, blood bank, abortion clinic, or an adult book or adult video tape store (which are defined as stores in which any portion of the inventory is not available for sale or rental to children under 18 years old because such inventory explicitly deals with or depicts human sexuality).

The purpose of this Memorandum of Lease is to give record notice of the Lease and of the rights created thereby, all of which are hereby confirmed.


