That at the special instance and request of said contractor the claimant furnished extra and additional materials at and extra labor on said premises of the value of \$11,000.00 and completed same on September 20, 1995.

That said contractor is entitled to credit on account thereof as follows: Partial payment of \$67,200.00, leaving due and owing to the claimant, after allowing all credits, the sum of Eleven Thousand (\$11,000.00) DOLLARS, for which, with interest, the claimant claims a lien on said land and improvements and on the moneys or other considerations due or to become due from the owner under said contract against said contractor and owner.
