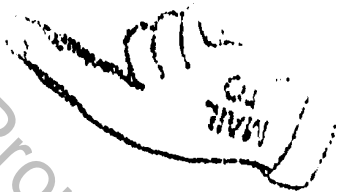

That part of the Fractional Section 7, Township 35 North, Range 13 East of the Third Principal Meridian described as follows:

Commencing at the intersection of the Indian Boundary Line and the West line of the Northwest 1/4 of said Fractional Section 7; thence North 1 degree 04 minutes 27 seconds West along said West line, 1269.46 feet; thence Southeasterly along a curve whose radius is 1990.08 feet and whose center point lies eastward, an arc distance of 308.51 feet; said curve being the Westerly right-of-way line of Harlem Avenue (IL. Rt. 43) as per Document #Z1145197; thence Southeasterly along a curve being the said Westerly right-of-way line whose radius is 1845.80 feet and whose center point lies Westerly, an arc distance of 396.12 feet; thence South 44 degrees 46 minutes 37 seconds West, 501.17 feet to the point of beginning in Cook County, Illinois and containing 5.3783 acres.
