ORDINANCE REPEALING ORDINANCE
NUMBER 371-93 ENTITLED

"AN ORDINANCE ANNEXING THE PARK DISTRICT OF OAK FOREST,
COOK COUNTY, ILLINOIS, PROPERTY WITHIN THE UNINCORPORATED AREA
OF OAK FOREST NOT PREVIOUSLY IN SAID PARK DISTRICT,
WHICH PROPERTY IS DESCRIBED IN THIS ORDINANCE AND
LIES WHOLLY WITHIN THE COUNTY OF COOK AND STATE OF ILLINOIS"

WHEREAS, the Corporate Authorities of the Oak Forest Park
District have previously annexed certain property to the Oak Forest
Park District; and

WHEREAS, said annexation ordinance has previously been
recorded; and

WHEREAS, it is the desire of the Corporate Authorities of
the Oak Forest Park District to take all steps necessary to insure
that the property is not considered annexed to the Oak Forest Park
District for taxing or any other purposes.

NOW, THEREFORE, Be It Ordained by the President and the
Board of Commissioners of the Oak Forest Park District, Cook
County, Illinois, as follows:

Section 1: Ordinance No. 371-93 entitled "AN
ORDINANCE ANNEXING THE PARK DISTRICT OF OAK FOREST, COOK COUNTY,
ILLINOIS, PROPERTY WITHIN THE UNINCORPORATED AREA OF OAK FOREST NOT
PREVIOUSLY IN SAID PARK DISTRICT, WHICH PROPERTY IS DESCRIBED IN
THIS ORDINANCE AND LIES WHOLLY WITHIN THE COUNTY OF COOK AND STATE
OF ILLINOIS" be and is hereby repealed and shall be of no further
force and effect. The legal description of the territory set forth
in said Ordinance No. 371-93 is set forth on the exhibit attached
hereto and made a part hereof as Exhibit "A". It is the intent and
effect of this Ordinance that such property so legally described
shall not be considered incorporated within the limits of the Oak
Forest Park District for any reason whatsoever and that no Park
District taxes be extended for any portion of the year 1994 against
such property.
