SECOND LOAN MODIFICATION AGREEMENT + J.J *-95-878994

THIS AGREEMENT, IN made and entered into as of November 28, 1995, but made effective as of October 10, 1995, by and between MID TOWN BANK AND TRUST COMPANY OF CHICAGO, AD Illinois corporation ("BANK"), AMERICAN NATIONAL BANK AND TRUST COMPANY OF CHICAGO, NOT PERSONALLY BUT AS TRUSTEE UNDER TRUST AGREEMENT DATED 7/7/86 A/K/A TRUST NO. 067922-04 ("BORROWER") and NORMAN PERLMUTTER ("GUARANTOR").

WHEREAS:

- 1. The BORROWER has heretofore executed a Promissory Note dated October 10, 1986, in the principal amount of \$62,500.00, of which the BANK is presently the holder;
- The NOTE is secured by a Trust Deed dated October 10, 1986, and recorded in the Recorders Office of Cook County, Illinois, as document number 87141257 ("TRUST DEED"), conveying to TRUSTEE certain real estate described in Exhibit "A" attached hereto and by this reference incorporated herein ("REAL ESTATE");
- 3. The NOTE is further secured by an Assignment of Rents of even date therewith and recorded in the Recorders Office of Cook County, Illinois as document number 87141258, ("ASSIGNMENT OF RENTS") assigning all the rents and profits from the REAL ESTATE;
- The NOTE is further secured by a Collateral Assignment of the Beneficial Interest in that certain Land Trust which is known as American National Bank and Trust Company of Chicago a/t/u Trust Agreement dated 7/7/86 a/k/a Trust No. 067922-04 ("ASSIGNMENT OF BENEFICIAL INTEREST") which land trust holds title to the described REAL ESTATE;
- 5. The NOTE is further secured by a Personal Guaranty ("GUARANTY") dated of even date therewith and executed by the GUARANTOR guaranteeing repayment of the indebtedness evidenced by said NOTE;
- 6. The BANK has disbursed to BCRROWER the sum of \$62,500.00, which amount represents the entire principal sum of the indebtedness evidenced by the NOTE;
- 7. The interest rate evidenced on said NOTE is the Prime Rate of interest in effect from time to time at Mid Town Bank and Trust Company of Chicago the prime rate is subject to change;

- 8. The NOTE AND TRUST DEED were modified by a Loan Modification Agreement ("MODIFICATION AGREEMENT") dated December 14, 1992, but made effective as of October 10, 1992, and recorded in the Recorders Office of Cook County, Illinois, as document number 93019793 wherein the repayment terms and maturity date were amended;
- The BORROWER desires to amend the maturity date evidenced by the NOTE and amended by the MODIFICATION AGREEMENT;;
- in 10. The BANK has agreed to such modification pursuant to the terms and conditions of a commitment of the BANK dated November 28, 1995 ("COMMITMENT").

NOW THEREFORE, notwithstanding anything contained to the contrary in the NOTE, TRUST DEED, ASSIGNMENT OF RENTS, AND GUARANTY, and in consideration of the mutual covenants, conditions, and premises contained herein, the PARTIES HERETO AGREE AS FOLLOWS:

- A. The principal amount evidenced by the NOTE as of this date is \$58,230.83.
- B. Principal payments in the amount of \$100.00, plus interest on the outstanding principal balance, shall continue to be due and payable monthly beginning November 1, 1995, and on that day each month thereafter until all of said outstanding principal plus any remaining accrued interest and late charges, if any, are repaid in full.
- C. The maturity date is hereby amended to October 10, 1998.
- D. Except as modified herein, the terms, covenants and conditions of the TRUST DEED, ASSIGNMENT OF RENTS AND GUARANTY shall remain unchanged and otherwise in full force and effect. In the even of any inconsistency between the terms of this agreement and the terms of the NOTE and/or MORTGAGE, ASSIGNMENT OF RENTS AND GUARANTY, the terms herein shall control.
- E. The lien of the TRUST DEED is hereby modified as security for the payment of the principal sum evidenced by the NOTE and amended by this SECOND MODIFICATION AGREEMENT.
- F. This agreement shall be governed by and construed under the laws of the State of Illinois.
