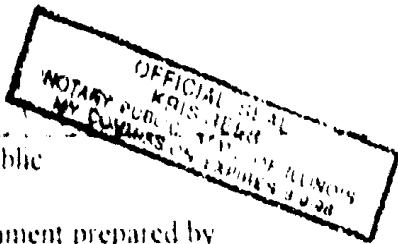

PARCEL I:

Unit No. 1028, as delineated on the survey of the following described real estate (hereinafter referred to as "Parcel I"):

That part of the Southeast 1/4 of fractional Section 10, Township 41 North, Range 12, East of the Third Principal Meridian, described as follows: Commencing at the Southeast corner of the aforesaid Southeast 1/4 of Section 10; thence North 340.98 feet along the East line of said Southeast 1/4; thence West 152.69 feet along a line drawn perpendicular to the East line of said Southeast 1/4, to the point of beginning of the herein described tract of land; thence continuing West 182.98 feet along the westerly extension of said perpendicular line; thence North 73.50 feet along a line drawn parallel with the East line of the aforesaid Southeast 1/4; thence East 182.98 feet along a line drawn perpendicular to the East line of the aforesaid Southeast 1/4; thence South 73.50 feet along a line drawn parallel with the East line of the aforesaid Southeast 1/4, to the hereinabove designated point of beginning, in Cook County, Illinois, which survey is attached as Exhibit "B" to Declaration of Condominium Ownership and of Easements, Restrictions and Covenants for Courtland Square Condominium Building No. 4 made by Harris Trust and Savings Bank, as Trustees under Trust Agreement dated February 28, 1979 and known as Trust No. 1912, and recorded July 17, 1979 as Document No. 25,051,437, together with an undivided 5.99454 percent interest in said Parcel (excepting from said Parcel all the units thereof as defined and set forth in said Declaration of Condominium Ownership and survey).
