CONDOMINIUM RIDER

THIS CONFORMINIUM RIDER is made this 15TH day of DECEMBER, 1995 and is incorporated into a number of the decement to amond and supplement the Mortgage, Deed of Trust or Security Deed (the "Security Instrument", of the same date given by the undersigned (the "Botrower") to secure Botrower's Note to SOUTHERN PROIFIC FUNDING CORPORATION, A CALIFORNIA CORPORATION

(the "Lender") of the same date and covering the Property described in the Security Instrument and located at:

540 NORTH LAKE SHORE DRIVE #517 CHICAGO, IL 60611

The Property includes a unit in, together with an undivided interest in the common elements of, a condominium project known as: 540 LAKE SHORE DRIVE CONDOMINIUMS

(the "Condominium Project"). If the owners association or other entity which acts for the Condominium Project (the "Owners Association") holds title to property for the benefit or use of its members or shareholders, the Property also includes Borrower's interest in the Owners Association and the uses, proceeds and benefits of Borrower's interest.

CONDOMINIUM COVENANTS. In addition to the covenants and agreements made in the Security Instrument, Borrower and Lender further covenant and agree as follows:

- A. Condominium Obligations. Borrower shall perform all of Borrower's obligations under the Condominium Project's Constituent Documents. THE NOTE CONTAINS PROVISIONS ALLOWING FOR CHANGES IN THE INTEREST RATE AND THE MONTHLY PAYMENT, THE NOTE LIMITS THE AMOUNT THE BORROWER'S INTEREST RATE CAN CHANGE AT ANY ONE TIME AND THE MAXIMUM RATE THE BORROWER MUSTICAL.

(F) Notice of Changes

The Note Holder will deir er or mail to me a notice of any changes in my interest rate and the amount of my mountly payment before the effective date of any change. B. TRANSFER OF THE PROPERTY OR A BENEFICIAL INTEREST IN BORROWER

Uniform Covenant 17 of the Security Instrument is amended to read as follows:

Transfer of the Property or a Beneficial Interest in Borrower.
