Maintenance of insurance. Grantor shall produce and maintain policies of fire insurance with standard extended coverage enduragements on a replacement basis for the full insurable value covering all improvements on the Real Property in an amount sufficient to avoid application of any coinsurance clause, and with a standard mortgagee Clause in favor of Lender. Policies shall be written by such insurance companies and in such form as may bit reasonably acceptable to Lender.
