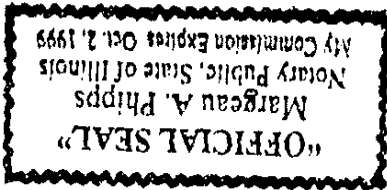

PARCEL 1: Lot 3 in Block 1 in Paloe Dells, being a Subdivision of the Northeast 1/4 of the Southwest 1/4 of Section 26, Township 57 North, Range 12, East of the Third Principal Meridian (except therefrom that part lying North of the Wabash Railroad and the right of way of the said railroad and also except that triangular shaped piece of land conveyed to Wabash Railroad by Deed from Chicago Sharpshooter Association [a corporation] dated on March 23, 1915 and recorded March 31, 1915 as Document Number 13368, Page 108), in Cook County, Illinois.

PARCEL 2: Easement for the benefit of Parcel 1 as created by Deed from Dorothy B. Radosevich to William P.
