# FIRST AMENDMENT TO DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS FOR UNOCAL'S SCHAUMBURG OFFICE/COMMERCIAL DEVELOPMENT

This instrument is the First Amendment dated the ZOH day of December, 1995 (the "First Amendment") to the Declaration of Covenants, Conditions and Restrictions for Unocal's Schaumburg Office/Commercial Development dated March 22, 1993 (the "Declaration").

#### RECITALS

- A. Union Oil Company of California, a California corporation, Route 58 Corporation, a Delaware corporation, and Unocal Land and Development Company, a California corporation, have entered into the Declaration dated March 22, 1993 and recorded with the Cook County, Illinois Recorder on May 10, 1993 as Document No. /3350375 with respect to the property described in Exhibit "A" hereto (the "Property").
- B. Union Oil Company of California is the successor through merger to Route 58 Corporation.
- C. Union Oil Company of California and Unocal Land and Development Company collectively own one hundred percent (100%) of the Property.
- D. Union Oil Company of California and Unocal Land and Development Company, as Seller, have entered into an agreement with IKEA Property, Inc., as Purchaser, for the sale of that part of the Property which is described in Exhibit "B" hereto (the "IKEA Property").
- E. IKEA will use the IKEA Property for a retail furniture store, ancillary restaurant and related uses.
- F. Union Oil Company of California, Unocal Land and Development Company, IKEA Property, Inc., the Village of Schaumburg, Illinois, Roosevelt University and Community Center One LLC have approved and agreed to execute the Third Amended and Restated Annexation Agreement For Unocal Property Schaumburg, Illinois dated December 12, 1995 which provides in Section 30 as follows:

The Parties hereby agree, state and direct that the IKEA Parcel be, and the same hereby is, released from all benefits, burdens, rights and obligations accruing to it under the "Declaration by Union Oil Company, A California Corporation, Route 58 Corporation, A Delaware Corporation, and Unocal Land and Development Company, A California Corporation, of Covenants, Conditions and Restrictions for Unocal's Schaumburg Office/Commercial Development" recorded with the Recorder of Deeds for Cook County, Illinois on May 10, 1993 as Document No. 93350375, and that said Declaration is without force or effect as to the IKEA Parcel. This Paragraph 30 shall survive the termination of this Third Amendment.

Third Amended 1000 Restated Annexation Agreement, Union Oil Company of California and Unocal Land and Development Company hereby agree, state and direct that the IKEA Property be, and the same hereby is, released from all benefits, burdens, rights and obligations accruing to it under the "Declaration by Union Oil Company, A California Corporation, Route 58 Corporation, A Delaware Corporation, and Unocal Land and Development Company, A California Corporation, of Covenants, Conditions and Restrictions for Unocal's Schaumburg Office/Commercial Development" recorded with the Resorder of Deeds for Cook County, Illinois on May 10, 1993 as Document No. 93350375, and that said Declaration is without force or effect as to the IKEA Property.
