3. Application of Payments. - 4. Prior Mortgages and Deeds of Trust; Charges; Liens. Extension of the time for payment or modification of amortization of the sams secured by this Mortgi ge granted by Lender to any successor in interest of Borrower shall not operate to release, in any manner, the liability of the original Borrower and Borrower's successors in interest. Lender shall not be required to commence proceedings against such success/r or refuse to extend time for payment or otherwise modify amortization of the sums secured by this Mortgage by reason of any demand made by the original Borrower and Borrower's successors in interest. Any forbestance by Lender in exercising say right or remedy hereunder, or otherwise afforded by applicable law, shall not be a waiver of or preclude the exercise of any so. a right or remedy.
- 11. Successors and Assigns Bound; Joint and Several Liability, Co-signers. The covenants and agreements herein contained shall blad, and the rights hereunder shall inure to, the respective successors and assigns of Londer and Borrower, subject to the provisions of paragraph 16 hereof. All covenants and agreeme us of horrower shall be joint and several.
