If you require, I will promptly give to you all receipts of paid premiums and renewal notices. In the event of a loss, I will give prompt notics to the insurance carrier and you. You may file proof of loss if not made promptly by me. Insurance proceeds will be applied to the restoration or repair of the Property damaged or, at your option, the insurance proceeds will be applied to the sums, secured by this mortgage, whether or not the due, with any excess paid to me. If I shendon the Property, or do not enswer within ten (10) days, a notice from you that the immense currier has offered to settle a claim, then you may collect the insurance proceeds. The ten (10)-day period will begin when the notice is given.

TITLE - I warrant the title to the Property. I further warrant that the lieu created by this mortgage is a valid and enforceable first lieu, subordinate only to casements and restrictions of record existing as of the date of this mortgage, and that during the entire term of indebtedness secured by this mortgage such lieu will not become subordinate to enything class.

I agree to pay all costs and disbursements (including reasonable attorze) fees) to which you are legally entitled in connection with any suit to foreclose on or collect this mortgage. If any money is left over after you foreclose on this mortgage and deduct such costs and disbursements, it will paid to the persons legally entitled to it, but if any money until owing, I agree to pay you the balance.

EXTENSIONS AND MODIFICATIONS - Each of the undersigned agrees (as) no extension of time or other variation of any obligation secured by this mortgage will affect any other obligations under this mortgage.

APPLICABLE LAW - This mortgage is made in accordance with, and will be consisted under, the laws of the State of Illinois, and applicable federal law.

FORECLOSURE - In the event that any provision of this mortgage is inconsistent with any provision of the Illinois Mortgage Foreclosure Law Chapter 110, Sections 15-1101 et. seq., 111. Rev. Stat., as amended ("Act"), the provisions of the Act shall take precedence over the provisions of this mortgage, but shall not invalidate or render unenforceable any other provision. of this mortgage that can be construed in a manner consistent with the Act. If any provision of this mortgage shall grant you any rights or a medies upon my default which are more limited than the rights that would otherwise be vested in you under the Act in the absence of said provision, you shall be vested with the rights granted in the Act to the full extent permitted by law.

MAXIMUM AMOUNT - The maximum amount of principal, interest, future advances and other amounts (n) w or hereisafter owed) that shall be secured by this mortgage shall be double the original principal balance hereinabove stated.

RESPONSIBLE PARTY TRANSFER ACT - I represent and warrant that the Property does not contain any waterground storage tanks or conditions which require notification or compliance with the Responsible Party Transfer Act of 1988, as an a set (Itilinois Annotated Statutes, Chapter 30, Paragraph 901 et. seq.), in conjunction with the execution and delivery of this morngage.

EXCESS INTEREST - It being the intention of you and me to comply with the laws of the State of Ulinois and applicable federal law, it is agreed that notwithstanding any provision to the contrary in the Note, this mortgage, or any of the other loan documents, no such province shall require the payment or permit the collection of any amount ("Excess Interest") in excess of the maximum amount of interest permitted by law to be charged for the use or detention, or the forbearance in the collection, of all or any portion of the indebtedness hereby secured.
