That at the special instance and request of said contractor the claimant furnished extra and additional materials at and extra and additional labor on said premises of the value of Five Thousand One Hundred Fifty-Nine and 5/100 Dollars (\$5,159.05) and completed same on November 4, 1994.

That said contractor is entitled to credits on account thereof as follows: Seventy Two Thousand Four Hundred Forty-Five and 50/100 Dollars (\$72,445.50) leaving due, unpaid and owing to the claimant, after allowing all credits, the sum of Twenty Five Thousand Eight Hundred Thirteen and 55/100 Dollars (25,813.55), for which, with interest, the claimant claims a lien on said land and improvements and on the moneys or other considerations due or to become due from the owner under said contract against said contractor and owner.
