Together With all the improvements now or hereafter erected on the property, and all easements, rights appurtenances, rents, royalties, minerals, oil and gas rights and profits, water, water rights, and water stock, and all fixtures now or hereafter attached to the property covered by this Mortgage; and all of the foregoing, together with the said property (or the leasehold estate if this Mortgage is on a leasehold) are herein referred to as the "Property.

Borrower Covenants the Borrower is lawfully selzed of the estate hereby conveyed and has the right to mortgage, grant and convey the Property, and that the Property is unencumbered except for encumberances of record. Borrower warrants and will defend generally the title to the Property against all claims and demands, subject to any encumberances of record.

Covenants, Borrower covenants and agrees as follows:

1. Payment of Principal and Interest. Borrower shall promptly pay when due the principal of and interest on the indebtedness incurred pursuant to the Note, together with any fees and charges provided in the Note and Agreement.

- 2. Application of Payments. - 3. Charges; Liens. Borrower shall pay or cause to be paid all taxes, assessments, and other charges, fines, and impositions attributable to the Property that may attain priority over this Mortgage, leasehold payments or ground rents, if any, and all payments due under any mortgage disclosed by the title insurance policy insuring the Lender's interest in the Property(the "First Mortgage"), if any. Upon Lender's request, Borrower shall promptly furnish to Lender receipts evidencing payments of amounts due under this paragraph. Borrower shall promptly discharge any lien that has priority over this Mortgage, except the lien of the First Mortgage; provided that Borrower shall not be required to discharge any such lien so long as Borrower shall, in a minner acceptable to Lender, agree in writing to the payment of the obligation secured by such lien or contest or detend an orderness to be under the property or any part thereof.

4. Hazard Insurance. Borrower shall keep the improvements now existing or hereafter erected on the Property insured against loss by lire, hazards included within the term "extended coverage", and such other hazards as Lender may require and in such amounts and for such periods as Lender may require; provided that Lender shall not require that the amount of such coverage exceed that amount of coverage required to pay the total amount secured by this Mortgage, taking prior

\* 8. Condemnation. The proceeds of any award or claim for damages, direct or consequential, in connection with any condemnation or other taking of the Property, or part thereof, or for conveyance in flew of condemnation, are hereby easigned and shall be priced to the Property, the proceeds shall be applied to the sums secured by the Mortgage, with the excess, it any, paid to Borrower in the event of the partial taking of the Property, unless Borrower and Lender otherwise agree in writing, the sums secured by this Mortgage shall be reduced by the amount of proceeds multiplied by the following fraction: (a) the total amount of the sums secured by this Mortgage immediately before taking, divided by (b) the fair market value of the Property immediately before the taking. Any balance shall be paid to the Borrower.

If the Property is abandoned by the Borrower, or, if, after notice by the Lender to Borrower that the condemnor has offered to make an award or settle a claim for dumages, Borrower falls to respond to Lender within 30 days after the date such notice is mailed. Lender is authorized to collect and apply the proceeds, at Lender's option, either to restoration or repair of the Property or to the sums secured by this Mortgage, whether or not yet due. - 10. Forbearance by Lender Not a Walver. Any forbearance by Lender in exercising any right or remedy shall not be a waiver of or practice the examples of any right or remedy.
- 11. Successors and assigns Eound; Joint and Several Liability; Captions. The covenants and agreements herein contained shall bind, and the reghts hereunder shall inure to the respective successors and assigns of Lender and Borrower. All covenants and agreements of Borrover shall be joint and several. The captions and headings of the paragraphs of this Mortgage are for convenience only and arc not to be used to interpret or define the provisions hereof.
- 12. Notice. Except for any notice required under applicable law to be given in any manner, (a) any notice to Borrower provided for in this Mortgage shall be given by mailing such notice by certified mail addressed to Borrower at the Property Address or to such other address as Borrower may designate by notice to Lender as provided herein, and (b) any notice to Lender shall be given by certified mail, return receipt inquested, to Lender's address stated herein or to such other address as Lender may designate by notice to Borrower provided herein. Any notice provided for in this Mortgage shall be deemed to have been given to Borrower or Lender when given in the manner designated herein.
- 13. Governing Law; Severability. This Mortgage shall be governed by the laws of Illinois. In the event that any provision or clause of this Mortgage, the Note or the Agreement conflicts with an plicable law, such conflict shall not affect the other provisions thereof which can be given effect without the conflicting provisions. To this end the provisions of the Note, the Agreement, and this Mortgage are declared severable.
- 14. Transfer of Property. To the extend permitted by law, if all or any part of the Property or any interest therein, including without limitation any beneficial interest in any trust holding title to the Property, is sold or transferred by Borrower without Lender's prior consent, Lender may, at Lender's option, declare all sums secured by this Mortgage to be appreciately due and payable.
- 15. Revolving Credit Loan. This Mortgage is given to secure a revolving credit loan as authorized by Section 5d of the tilinois Banking Act (III. Rev. Stat., Ch. 17, par. 312.3) and shall secure not only presently existing indebtedness under the agreement but also future advances, whether such advances are obligatory or to be made at the ortion of the Lender, or etherwise, as are made within 10 years from the date hereof, to the same extent as if such future advances were made on the date of the execution of this Mortgage and although there may be no indebtedness outstanding at the time any advance is made. The lien of this Mortgage shall be valid as to all indebtedness secured hereby, including future advances, from the time of its filling for record in the recorder's or registrar's office of the county in which the Property is located. The total amount of indebtedness secured hereby may increase or decrease from time to time, but the total unpaid balance secured hereby at any one time shall not exceed the Credit Limit, plus interest thereon, and any disbursements made for payment of taxes, special assessments, or insurance on the Property and interest on such disbursements. This Mortgage shall be valid and have priority over all subsequent liens and incumberances including statutory liens, excepting solely taxes and assessments levied on the Property given priority by law. levied on the Property given priority by law.
- 16. Acceleration; Remedies. Upon occurrence of an Event of Default under the Note or the Agreement; which Events of Default are incorporated herein by this reference as though set forth in full herein, Lender at Lender's option may declare all sums secured by this Mortgage to be immediately due and payable without further demand, may ferminate the availability of loans under the Agreement, and may foreclose this Mortgage by judicial proceeding. Lender shall be entitled to collect in such proceeding all expenses of foreclosure, including, but not limited to, reasonable attorney's fees, and costs of documentary evidence, abstracts, and the title reports. All remedies provided in this Mortgage are distinct and cumulative to any other right or remedy under this Mortgage, the Note, the Agreement, or afforded by law or equity, and may be exercised concurrently, independently, or successively.

17. Assignment of Rents; Appointment of Receiver; Lender in Possession. As additional security hereunder, Borrower hereby assigns to Lender the rents of the Property, provided that Borrower shall, prior to acceleration under paragraph 16 hereof or abandonment of the Property, have the right to collect and retain such rents as they become due oklayağı bun

All rents collected by Lender or the receiver shall be applied first to payment of the costs of management of the Property and collection of rents including, but not limited to, receiver's fees, premiums on receiver's bonds and reasonable attorney's fees, and then to the sums secured by this Mortgage. Lender and the receiver shall be liable to account only for those rents actually received.

- 18. Release. Upon payment in full of all amounts secured by this Mortgage and termination of the Agreement, Lender shall release this Mortgage without charge to Borrower.
  - 19. Walver of Homestead. Borrower hereby walves all homestead exemption in the Property.
- 20. This Mortgage shall secure any and all renewals, extensions or modifications of the whole or any part of the indebtedness hereby secured, however evidenced, with interest at such lawful rate as may be agreed upon and any such renewals, extensions, modifications or chande in terms or rate of interest, shall not impair in any manner the validity or priority of this Mortgaga, nor release the Mortgagor or any Co-maker, surety or guarantor of the indebtedness secured hereby from personal liability.
