UNIFORM COVENANTS. Borrower and Lender covenant and agree as follows:

1. Payment of Principal and Interest; Prepayment and Late Charges. Borrower shall promptly pay when due the principal of and interest on the debt evidenced by the Note and any prepayment and late charges due under the Note.

2. Funds for Taxes and Insurance. Additional Covenants. In addition to the covenants and agreements made in the Security Instrument, Borrower and Lender

The Note provides for an initial interest rate of 5.375 %. The Note provides for changes in the interest rate and the monthly payments, as follows:
