IT IS HEREBY ORDERED:

1. That the Motion of Defendant/Counter Plaintiff, ANGELO S. RECOPOLOUS, Efstathios A. RECOPOLOUS and JOSEPH NAVILIO, for directed finding in it's favor at the close of Plaintiff/Counter Plaintiff's, LOUIS PACINI and LOIS PACINI, and LA SALLE NATIONAL BANK, a national banking association, as Trustee under Trust Agreement dated December 22, 1986 and known as Trust No. 111927, case in chief is granted. Therefore, relative to Plaintiff/Counter-Defendant's complaint finding in favor of Defendant/Counter Plaintiff.

That Defendant/Counter-Plaintiff's, ANGELO S. RECOPOLOUS, Efstathios A. RECOPOLOUS and JOSEPH NAVILIO, counter claim is granted and judgment is entered in favor of Defendant/Counter-Plaintiff and against Plaintiff/Counter-Defendant's, LOUIS PACINI and LOIS PACINI, and LA SALLE NATIONAL BANK, a national banking association, as Trustee under Trust Agreement dated December 22, 1986 and known as Trust No. 111927 in the amount and amounts as follows:
