#### AN ORDINANCE

Annexing the South 150 feet of Lots 72 and 73 in Dixie Gardens, being a subdivision of the Southwest quarter of the Northwest quarter of Section Seventeen (17), and the Southeast quarter of the Northeast quarter and the Northeast quarter of Section 18, all in Township 35 North, Range 14, East of the Third Principal Meridian in Cook County, Illinois.

EDWARD T. HARVEY and FAYE HARVEY, his wife, have petitioned the City of Chicago Heights, Illinois, requesting that the following described property, to-wit:


