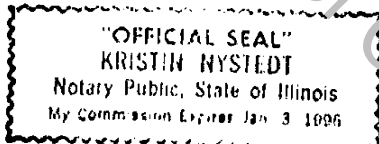

Permitted Encumbrances

1. General real estate taxes for the year 1994 and subsequent years;
2. Declaration of Covenants, Conditions, Restrictions and Rights dated April 25, 1994;
3. Easement Grant dated May 27, 1994;
4. Plat of Subdivision of Priory Estates of River Forest recorded June 23, 1994 as document 94558271;
5. Acts done or suffered by or through the Grantee;
6. This conveyance is subject to the right (but not the obligation) of Grantor to repurchase the property conveyed hereby for the original consideration paid by Grantee, (subject to customary closing prorations and conditions), in its present condition (or better) and subject to no additional exceptions or encumbrances other than those listed hereon, if Grantee or its successors or assigns have not on or before two (2) years from the date hereof: (a) received "Architectural Approval" to construct a "Dwelling Unit" as such terms are defined in and pursuant to that certain Declaration of Covenants, Conditions, Restrictions and Rights made by the Dominicans Province of St. Albert the Great, USA, dated April 25, 1994 (the "Covenants"); and (b) been issued all appropriate permits by the Village of River Forest (and any other necessary governmental units) to commence construction thereon. Such right of repurchase shall be exercisable by written notice to the then-current owner of record on or before July 18, 1997. In the event such notice is delivered, the then-current owner and Grantor shall work in good faith to reconvey the property within 30 days and in accordance with local practice and customs.

Grantee further acknowledges that no person or entity or their respective majority-owned affiliates may own, directly or indirectly, legally or beneficially, more than three Residential Lots (as defined in and subject to Covenants) at any time or from time to time.

Grantee further agrees, at Grantee's sole cost and expense, to cause new sidewalks to be installed across the property conveyed hereby or on the public right-of-way adjacent to the property conveyed hereby, which installation shall be

subject to the approval and the direction of the Village of River Forest.
