





Pare, Jr., in his capacity as Receiver of of Greater Providence Deposit Corporation, Greater Providence Trust Company and Community Loan & Investment Bank (collectively, the "Receiver" and the "Credit Unions" respectively) and not in their individual capacities, each hereby irrevocably appoints Northeast Savings, F.A., a federally chartered stock savings association having its principal office located in Hartford, Connecticut ("Northeast"), and the successors and assigns of Northeast, acting by and through its Chairman, Chief Executive Officer, President, Vice President, Treasurer, Secretary, or any of its Executive Vice Presidents, Senior Vice Presidents, Vice Presidents, Assistant Vice Presidents, or Assistant Treasurers, to be his true and lawful attorney as his agent and attorney-in-fact, and in his name, place and stead and with power of Receiver, in his own name and capacity as Receiver for the Credit Unions or in the name and capacity of Northeast, (i) to endorse notes, drafts or bills of exchange, (ii) to cash, endorse, and deposit checks payable to Receiver respecting the Credit Unions or any of the Credit Unions, (iii) to give receipts, discharges, releases and acquittances for or in respect of any indebtedness owed to Receiver or any of the Credit Unions, and any security given for such indebtedness, (iv) to execute, acknowledge, and deliver any and all such other further deeds, assignments, transfers, conveyances, notices, confirmations, affidavits, powers of attorney, and any instruments of further assurance, approvals, and consents deemed necessary and proper in order to service, protect, and manage the foregoing, (v) to do any other acts required to carry out said powers including substitution of any other person as agent aforesaid, and (vi) to execute any and all instruments (including without limitation assignments, endorsements, transfers and conveyances) and further assurances; in each case solely to the limited extent necessary to consummate the transactions contemplated by the Acquisition Agreement dated as of April 21, 1992, by and among Northeast, Maurice C.
