LOAN MODIFICATION AGREEMENT

This Loan Modification Agreement ("Agreement") made this 14TH day of NOVEMBER, 1994, between Daniel Landeros and Angelina Navarro ("Borrower") and Citibank, F.S.B. ("Lender"), amends and supplements (1) the Mortgage, Deed of Trust or Deed to Secure Debt (the "Security Instrument"), dated May 23, 1991 and recorded in Book or Liber _____, at page(s) _____ OR Document/Instrument # 91257604 of the Recorder's Office of Cook County, Illinois

In consideration of the mutual promises and agreements exchanged, the parties hereto agree as follows (notwithstanding anything to the contrary contained in the Note or Security Instrument):

1. As of December 1, 1994 the amount payable under the Note and Security Instrument (the "Unpaid Principal Balance") is U.S. \$ 119,009.17, consisting of the amount(s) loaned to the Borrower by the Lender and any interest capitalized to date.
2. The Borrower promises to pay the Unpaid Principal balance, plus interest, to the order of the Lender. Beginning on December 1, 1994, interest on the Unpaid Principal Balance will be reduced from a yearly rate of 10.25% to the yearly rate of 9.25% (the "rate of interest"). The Borrower promises to make monthly payments of principal and interest of U.S. \$ 1002.82 beginning on the 1st day of January, 1995 and continuing thereafter on the same day of each succeeding month until principal and interest are paid in full.

The Borrower will make payments at Citicorp Mortgage, Inc., 15851 Clayton Road, Ballwin, MO 63011 or at such other place as the Lender may require.

3. The Maturity Date of the Note and Security Instrument are extended from June 1, 2021 to July 1, 2021. If on the Maturity Date, the Borrower still owes amounts under the Note and the Security Instrument, as amended by this Agreement, the Borrower will pay these amounts in full on the Maturity Date.

The Borrower also will comply with all other covenants, agreements, and requirements of the Security Instrument, including without limitation, the Borrower's covenants and agreements to make all payment of taxes, insurance premiums, assessments, escrow items, impounds, and all other payments that the Borrower is obligated to make under the Security Instrument, including all terms and provisions of the Note.
5. Nothing in this agreement shall be understood or construed to be a satisfaction or release in whole or in part of the Note and Security Instrument. Except as otherwise specifically provided in this Agreement, the Note and Security Instrument will remain unchanged, and the Borrower and Lender will be bound by, and comply with, all of the terms and provisions thereof, as amended by this Agreement.

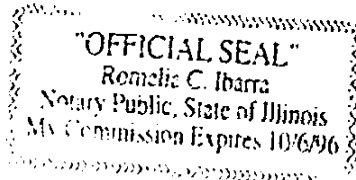

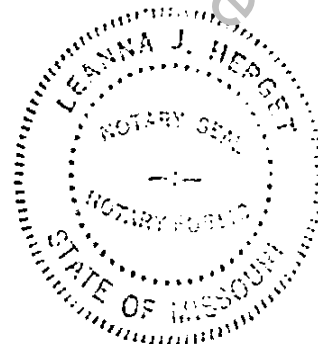
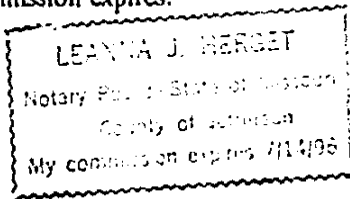
