IT IS HEREBY ORDERED:

1. The Court Hereby Reaches the Following ~~Verdict~~ FINDINGS:

A. As to Count One of the Third-Party Complaint of Currie Motors, Inc. (Fraud), the Court hereby finds that Third-Party Plaintiff has proved each element of common law fraud by clear and convincing evidence and, therefore, finds in favor of the Third-Party Plaintiff, Currie Motors, Inc. and against Third-Party Defendant, Edward A. Sakoff and awards damages in the amount of Forty-Six Thousand Four Hundred Twenty Nine and 75/100 Dollars (\$46,429.75); and

B. As to Count Two of the Third Party Complaint of Currie Motors, Inc. (Fraud), the Court hereby finds that Third Party Plaintiff has proved each element of common law fraud by clear and convincing evidence and, therefore, finds in favor of the Third Party Plaintiff, Currie Motors, Inc. and against Third Party Defendant, Edward A. Sakoff and awards damages in the amount of Six Thousand Seventy Eight and 50/100 Dollars (\$6,078.50);

C. The Court further finds that pursuant to the evidence received, an award of punitive damages as to all Counts would be inappropriate. It is Ordered that there be no judgment of punitive damages;

2. Pursuant to the foregoing, the Court hereby enters judgment on the verdict in favor of Third Party Plaintiff, Currie Motors, Inc. and against Third Party Defendant, Edward A. Sakoff in the amount of Fifty Two Thousand Five Hundred Eight and 25/100 (\$52,508.25) plus costs.
