WITNESSETH:

Assignor, for good and valuable consideration, receipt whereal is hereby acknowledged, and intending to be legally bound hereby grants, transfers and assigns to Assignee the entire Assigner's interest in and to all leases and other agreements affecting the use, enjoyment or occupancy of all or any part of that certain lot or piece of land, more particularly described in Exhibit "A" annexed hereto and made a part hereaf, together with the buildings, structures, fixtures, additions, enlargements, extensions, modifications, replacements and improvements now or hereafter located hereon (hereinafter collectively referred to as the "Modinged Property");

TOGETHER WITH all other leases and other agreements affecting the use, enjoyment or occupancy of the Nortenged Property or any portion thereof now or hereafter made, together with any extension or renewal of the same, this Assignment of other present and future leases and present and future agreements and any extension or renewal of same (hereinafter collectively referred to as the "Leases") being effective without further or supplemental assignment;

TOGETHER WITH any and all rights against any guaranter of any lessee's performance under any of the Lesses; and

TOGETHER WITH all rents, income, pauce and profits arising from the Loases and together with all rents, income, issues and profits (including all oil and gas or other mineral revalties and because) from the use, enjoyment and occupancy of the Mortgagod Property (hereinalter collectively referred to as the "Rents").

THIS ASSIGNMENT is made in consideration of that certain mortgage loan made by Assignee to Assigner evidenced by that certain Mortgage Note made by Assigner to Assignee, dated the date hereof, in the principal sum of Two Hundred Seventy Thousand and 00/100 Dollars (\$270,000.00) (the "Note"), and secured by that certain Mortgage and Security Agreement given by Assigner to Assignee, dated the date hereof, covering the Mortgaged Property and intended to be duly recorded (the "Mortgage"). The principal sum, interest and all other sums due and payable under the Note and Mortgage are collectively referred to as the "Debt". The documents, other than this Assignment, the Note and the Vortgage, now or hereafter executed by Assigner and/or others and by or in favor of Assignee which wholly or partially secure or guarantee payment of the Debt are hereinafter referred to as the "Other Security Deciments".

ASSIGNOR WARRANTS that (a) Assignor is the sole owner of the entire lessor's inferest in the Leases; (b) the Leases are valid and enforceable and have not been altered, modified or among the any manner whatsoever except as therein set forth; (c) none of the Rents reserved in the Leases have been assigned or otherwise piedged or hypothecated; (d) none of the Rents have been collected for more than one (1) month in advance; (e) Assignor has full power and authority to execute and deliver this Agreement and the execution and delivery of this Assignment has been duly authorized and does not conflict with or constitute a default under any law, judicial order or other agreement affecting Assignor or the Mortgaged Property; (f) the improvements to the premises demised under the Leases have been completed and the tenants under the Leases have accepted the same and have taken possession of the same on a rank paying basis; and (g) there exist no offsets or defenses to the payment of any portion of the Rents.

impair the value of the Leases as security for the Debt; (b) shall promptly send copies to Assignee of all notices of default which Assignor shall send or receive thereunder; (c) shall enforce all of the terms, covenants and conditions contained in the Leases and any guarantees thereof upon the part of the leases and the guaranters thereunder to be observed or performed, short of termination thereof; (d) shall not collect any of the Rents more than one (1) month in advance; (e) shall not execute any other assignment of lessor's interest in the Leases or the Rents; (f) shall not after, modify or change the terms of the Leases without the prior written consent of Assignee, or cancel or terminate the Leases or accept a surrender thereof or convey or transfer or suffer or permit a conveyance or transfer of the Mortgaged Property or of any interest therein so as to effect a merger of the estates and rights of, or a termination or diminution of the obligations of, lessoes thereunder; (g) shall not after, modify or change the terms of any guaranty of any of the Leases or cancel or terminate any such guaranty without the prior written consent of Assignee; (h) shall not consent to any assignment of or subletting under the Leases not in accordance with its terms, without the prior written consent of Assignee; and (i) shall execute and deliver at the request of Assignee all such further assurances, confirmations and assignments in connection with the Mortgaged Property as Assignee shall from time to time require.

ASSIGNOR FURTHER COVENANT'S with Assignee that (a) all Leases shall be written on the standard form of lease which has been approved by Assignee; (b) upon request, Assigner shall furnish Assignee with executed copies of all Leases; (c) no material changes may be made to the Assignee approved standard lease without the prior written consent of Assignee; (d) in addition, all renewals of Leases and all proposed leases shall provide for rental rates comparable to existing local market rates and shall be arms-length transactions; (e) all proposed leases shall be subject to the prior approval of the Assignee except that all proposed leases which (i) are on the same form of lease which has been approved by Assignee. (ii) are the result of an arms-length transaction, (iii) which provide for rental rates comparable to existing market rates, and (iv) do not contain any terms which would materially affect Assignee's rights under the Mortgage, the Note, the Other Security Decuments or this Assignment, shall not be subject to the prior approval of Assignee; and (f) all Leases shall provide that they are subordinate to the Mortgage and that the lessees agree to attorn to Assignee.

THIS ASSIGNMENT is made on the following terms, covenants and conditions:

GENERAL PROVISIONS

Present Assignment. Assignor does hereby absolutely and unconditionally assign to Assignee Assignor's right, title and interest in all current and future Leases and Rents, it being intended by Assignor that this assignment constitutes a present, absolute assignment and not an assignment for additional security only. Such assignment to Assignee shall not be constructed to bind Assignee to the performance of any of the covenants, conditions and provisions contained in any such Lease or otherwise impose any obligation upon Assignee. Assignor agrees to execute and deliver to Assignue such additional instruments, in form and substance satisfactory to Assignee, as may hereafter be requested by Assignee to lutther evidence and confirm such assignment. Nevertheless, subject to the terms of this paragraph 1, Assignee grants to Assignor a revocable license to operate and manage the Mortgaged Property and to collect the Rents. Assignor shall hold the Rents, or a portion thereof sufficient to discharge all current sums due on the Debt, in trust for the benefit of Assignee for use in the payment of such sums. Upon an Event of Delault (as defined in the Mortgage), the Ilcense granted to Assigner herein may be revoked, and Assignee shall immediately be entitled to possession of all Rents, whether or not Assignee enters upon or takes control of the Mortgaged Property. Assigned is hereby granted and assigned by Assignor the right, at its option, upon revocation of the Ilcense granted herein, to enter upon the Mortgaged Property in person, by agent or by court-appointed receiver to collect the Rents. Any Ronts collected after the revocation of the license may be applied toward payment of the Debt in such priority and proportions as Assignee in its discretion shall deem proper.

- Remedies of Assignee. Upon or at any time after an Event of Default, Assignee may, at its option, without waiving such Event of Default, without notice and without regard to the adequacy of the security for the Debt, either in person or by agent, with or without bringing any action or proceeding, or by a receiver appointed by a court, take possession of the Mortgaged Property and have, hold, manage, lease and operate the Mortgaged Property on such terms and for such period of time as Assignee may deem proper and, either with or without taking possession of the Mortgaged Property, in its own name, demand, sue for or otherwise collect and receive all Rents, including those past due and unpaid with full power to make from time to time all alterations, renovations, repairs or replacements thereto or thereof as may seem proper to Assigned and may apply the Rents to the payment of the following in such order and proportion as Assignee in its sole discretion may determine, any law, custom or use to the contrary notwithstanding: (a) all expenses of managing and security the Mortgaged Property, including, without being limited thereto, the salaries Joes and wages of a managing agent and such other employees or agents as Assigned may deem necessarily or desirable and all expenses of operating and maintaining the Mortgaged Property. including, without hoing limited therete, all taxes, charges, claims, assessments, water charges, sewer rents and any other lies, and promiums for all insurance which Assignee may deem necessary or desirable, and the cost of all alternions, renovations, repairs or replacements, and all expenses incident to taking and retaining possession of the Mortgaged Property; and (b) the Dobt, together with all contained attorneys' teas. In addition to the rights which Assigned may have herein, upon the occurrence of an Event of Default, Assigned, at its option, may ofther require Assigner to pay monthly in advance to Assignee, or any receiver appointed to collect the fights, the fair and reasonable rental value for the use and occupation of such part of the Mortgaged Property as may be in possession of Assignor or may require Assignor to vacate and surrender possession of the Mortgaged Property to Assignee or to such receiver and, in default thereof, Assigner may be evicted by summary proceedings or otherwise.
